Cancellation and change fees

- AIR Cancellation Policy:
 - 91 or more days prior to departure....

 No penalty
 - 90 days to 31 days prior to departure...
 A fee of \$50.00 per seat
 - Within 30 days of departure...
 Full fare for each seat not ticketed
- **LAND**(Hotel Josie, British Columbia, Canada): The penalties for hotels are getting more aggressive, which is a very good reason to have trip insurance.
 - The initial deposit of \$200 and the 2nd payment of \$600 are 100% refundable up to August 31, 2024. **Then hotel penalties are prorated as follows and these are aggressive:**
 - Sept 1 Oct 25: 50% penalty
 - 120 Days (Oct 25) to 91 Days(Nov 23) Days prior to arrival: 50% penalty
 - 90 Days(Nov 24) to 31 Days (Jan 22, 2025): 80% penalty
 - 30 days (Jan 23, 2025) prior to arrival: 100% penalty

TRIP INSURANCE:

I highly advise you get trip insurance as the hotel penalties are aggressive, see below:

I found a travel insurance company, Travel Protectors, LLC based in Leesburg, VA that has a solid reputation working with over 150 ski clubs annually. They provide reliable travel insurance options with companies that have excellent claims departments! They will even help you complete your claim so that it is settled quickly!

PLEASE NOTE! For those people who are interested in a "Cancel for Any Reason quote", keep in mind that you must purchase this plan within 14 days of the date of your down payment check.

Additional Details and key dates:

- Luggage fees by the airline is not included. Porterage of luggage, skis, etc is not included by Snow Tours, Inc. Currently airlines are charging \$40.00 for the first suitcase and \$50.00 for the second bag, if weighing no more than 50lbs. However, these prices are subject to change in 2025. Overweight and extra luggage will be charged by the air carrier. This luggage fee may change at any time without notice.
- I always recommend people rent skis/poles and bring their boots. I will find a rental place to get a
 discount for our club. Traveling with skis/poles comes with additional logistics and sometimes issues at
 airports. There are always exceptions for people wanting to bring their own but try to limit those
 exceptions.
- Due to the early flight on Saturday, February 22nd, I have booked a shuttle service to and from JFK for about \$100 pp. Currently I have 15 people booked but can add more if necessary. We can arrange to park our cars somewhere local while we are traveling.
- Any additional side trips are not included.
